**ORDER:**

In the reference G.O.1<sup>st</sup> read above, Government have formed a Special Purpose Vehicle (SPV) under the Companies Act, 2013, in line with the broad Objectives outlined for the development, implementation, operation and management of special projects to achieve the targeted development in the Amaravati Capital City and Region.

2. In the circumstances reported by the Commissioner, APCRDA in the reference 2<sup>nd</sup> read above, and consequent upon orders issued in the reference 1<sup>st</sup> read above, the Government hereby accord approval for the formation of a Special Purpose Vehicle (SPV) in the name of '**Amaravati Growth and Infrastructure Corporation Limited**' under the Companies Act, 2013.
3. The Government hereby notify the following for the purpose of incorporation of 'Amaravati Growth and Infrastructure Corporation Limited' with Registrar of Companies under the Companies Act, 2013.

**a) Objectives of the Special Purpose Vehicle (SPV) be named as '**Amaravati Growth and Infrastructure Corporation Limited** :**

- Undertake and execute the complete project lifecycle aspects covering planning, development, financing, implementation, operation, and management of Special Projects as envisaged by the APCRDA and the Government from time to time.
- Mobilize participation for Special Projects from public and private sector participants and structure projects under PPP (BOT, Hybrid-Annuity etc.), EPC, Operation & Maintenance, or other approved models.
- Function in close coordination with APCRDA for fund raising for SPV approvals, regulatory clearances, and inter-agency coordination within their sectoral mandates.
- Ensure compliance with all applicable regulatory, environmental, and social safeguard requirements.
- Institutionalize innovation, technology adoption, and capacity building within their respective sectors.

- Undertake the responsibility of contract administration for Special Projects for the entire Project Lifecycle.
- Revenue generation to APCRDA and/or government or to any
- State government entity through the special projects as agreed at the time of sanction of such special projects.
- Debt servicing to the Lenders to SPV wherever applicable without any default.
- Stakeholder management for Special Projects.
